**Billing Timetable 2019/20**

Invoices will be issued to retailers in accordance with the Wholesale Contract Schedule 1, Part 2: Business Terms. MOSL settlement report publication dates are available at:

<https://www.mosl.co.uk/calendar>.

In accordance with the business terms, P1 invoices will be issued no later than 14 business days prior to the start of the month that the invoice refers. For R1-RF settlement runs, invoices are required by MOSL to be issued within 10 business days of the publication of the relevant settlement report, although we aim to issue R1-RF invoices within 5 business days. Non-primary invoices will be issued within 5 business days of the 1<sup>st</sup> of the month following the month to which the invoice refers.
